Howard University provides an opportunity for alumni to nominate Alumni Trustee candidates to serve on the University's Board of Trustees. To be eligible, a nominee for Alumni Trustee must: (i) hold an earned degree from a college or school of the University; (ii) not be a full-time employee of the University; and (iii) have demonstrated a sustained and/or substantial commitment to the advancement of the University since the award date of the degree. United States citizenship is required of all Members of the Board.

The Howard University Alumni Association (HUAA) is responsible for developing a slate of candidates to be considered and voted by the general alumni population. The HUAA Nominating Committee will review the nominees to determine the slate using the following criteria: (i) contribution to Howard University; (ii) demonstrated leadership in the nominee's community, profession and/or public service; and (iii) involvement, contribution and membership in the Howard University Alumni Association.

Alumni must use the Official Nomination Credentials Form for Alumni Trustee to nominate individuals for the position. In addition to the information requested on this form, you are asked to submit a one page statement explaining why the nominee will be an asset to the Board of Trustees. Adequate biographical information on the nominee must be enclosed with this form to support your nomination. The Nomination Credentials Form, biographical information and statement must be received in the Department of Alumni Relations by **January 12, 2009**.
